



Information on the Right to Withdrawal
INSTRUCTIONS ON YOUR RIGHT TO WITHDRAWAL
(also valid in the event of an exchange)

Valued Customer, with reference to the General Terms and Conditions of Sale that were accepted by you, upon completion of a purchase on <http://www.rogervivier.com/> (the "Agreement"), we'd like to remind you of your:

Right to Withdrawal

You reserve the Right to Withdraw from the sales Agreement, without stating a reason, within 14 days of purchasing a product ("**Withdrawal Period**"):

- a) where the sale of goods agreement refers to a single product, from the day on which the customer or third party, different from the shipper and indicated by the customer themselves, materially acquires the product;
- b) where the sale of goods agreement relates to multiple products, ordered through a single order and dispatched through separate deliveries, from the day on which the customer or third party, different from the seller and indicated by the customer themselves, materially acquires the product.

In order to exercise your Right to Withdrawal, you are required to inform us (at the following address: Tod's S.p.A., Via Stendhal, 35, 20144 Milano, 08003681791, Fax +39 02 89623481, contact-rogervivier@todsgroup.com) of your intention to withdraw from the Agreement via an explicit declaration (E.g. mailed letter, fax or email). You may use the standard Right to Withdrawal Form attached hereto, but it is not mandatory.

In order to comply with the Withdrawal Period, it is enough for you inform us of your intention to withdraw before the expiry of the Withdrawal Period.

Withdrawal Effects

If you exercise your Right to Withdrawal, you will be refunded of any payments made to us, including delivery costs. This refund will be issued immediately and, in any case, within 14 days of being informed by you of your intention to withdraw from the Agreement. Should you choose to be refunded in a manner that differs from the payment methods made available to you, the refund will be issued within 3 working days of us receiving a package containing the product(s) that you wish to return; or, if you are able to provide sufficient evidence that these goods have been sent back to us. This refund will be made using the same payment method that you used at the time of the original purchase, unless separate arrangements were agreed upon; in any case, you will not be subject to any additional costs as a consequence of said refund.

In the event that a purchase was made through our online store via an enabled device in a boutique ("**Purchase in Endless Aisle Mode**"), please refer to Articles 11.6-*quater*, 11.6-*quinquies* and 11.7, in the General Terms and Conditions of Sale, which are available on the website.

With reference to the withdrawal from a Multiple Order, any related and additional delivery costs will not be refunded, save for the decision to withdraw from the entire Multiple Order.

You must send back or return the goods to us, without delay and, at any rate, within 14 days of informing us of your intention to withdraw from the Agreement ("**Return Period**"), using one of the procedures provided below.

Returning a Product from the same country in which it was delivered (as indicated in the order confirmation email):

1) Pre-paid Returns with UPS

We kindly ask you to return the goods for which you wish to exercise your right to withdrawal by using the courier UPS, and by attaching the prepaid and pre-filled label provided in the original box to the package. You may contact UPS at 03457 877 877 (fixed local toll, according to national operator costs; max cost 3.00 £/min, to arrange a date and place for pick-up of the goods you wish to return. In this case, you will not incur in any cost to return these goods – this will be handled by us, and, in addition, you will not be liable for any damages or loss of those goods during transit. ("**Pre-paid Returns through UPS**")

2) Returns to a Participating ROGER VIVIER Boutique

You may return any item(s) to the following ROGER VIVIER boutiques: London, 2-5 Old Bond Street, W1S 4PD; London, 35-36 Sloan Street, SW1 X9LP ("**Participating ROGER VIVIER Boutiques**") within the return period; in which case, the fees for returning any such item(s) through a participating ROGER VIVIER Boutique will be charged to Tod's S.p.A., which will assume liability for transporting the item(s).



In which case:

- if you have purchased products through the website, we would like to remind you that you must show the following to the Sales Assistant at the Participating ROGER VIVIER Boutique: (i) the original invoice for the purchase of those item(s) together with the related delivery confirmation email; (ii) a filled out Right to Withdrawal form (or one to be filled out at the Boutique); and (iii) the prepaid and pre-filled UPS label;
- If you purchased products in Endless Aisle Mode, we would like to remind you that you must show the following to the Sales Assistant at the Participating ROGER VIVIER Boutique: (i) the original invoice for the purchase of those item(s) together with the delivery confirmation email for those product(s); (ii) the sales receipt you received from the Boutique at the time of the Endless Aisle Purchase; (iii) a filled out Right to Withdrawal form (or one to be filled out at the Boutique); and (iv) the prepaid and pre-filled UPS label.

The Right to Withdrawal and/or return Products using one of the methods described in the paragraph below is only allowed at Participating ROGER VIVIER Boutiques; ROGER VIVIER stores other than Participating ROGER VIVIER Boutiques are not authorised to accept withdrawals and/or returns.

Return of Products to a different country with respect to where it was delivered (as indicated in the Order confirmation email) or via a courier of the Customer's choice (irrespective of country)

You may choose to return products via a courier of your choice and at your expense (including any applicable import tax), which you will be liable for ("**Return through a Courier of Choice**"). The product(s) must be returned to the following address: Tod's S.p.A. c/o Traconf Via Primo Maggio 19, 20010 Vanzago (MI), without delay and, in any case, within the Return Period. Where it is not possible to post any of these products due to their nature, the table below specifies the maximum estimated fees that we will charge to process this operation for you- the following table indicates costs by geographical area and product weight :
